## Northern Metals Recycling

Have you heard the good news? Well, hold the champagne...

Northern Metals Recycling (NMR) is indeed moving their vehicle shredder to a 75 acre site near Becker MN, but there is no plan at this time to shut down NMR’s existing scrap yard on the Mississippi River.

NMR is a subsidiary of EMR, a privately held off-shore multinational conglomerate that runs scrap operations all over the world. Feeding the market for steel is their core business. Scott Helberg, the plant manager at NMR, has said the company is willing to entertain a reasonable offer to move the remaining operations off the Mississippi River in the future but, for the time being, NMR Minneapolis will remain a metals recycler on its current site, crushing and baling metals for direct shipment to copper, steel, aluminum and other metal mills in the US and beyond.

Why should we care? Because particulate levels of 10 PM (parts per million) sized pollutants were recorded in the Lowry Bridge area as recently as April 24 and 27, exceeding allowed air standards. That meant it wasn’t safe for people who suffer from asthma to go outside on those days. Exercising outside under these air conditions is not recommended, either.

On April 30, in an MPCA news update, Assistant Commissioner David

Thornton said “if particulate levels are not brought under control soon, the MPCA may seek to pursue enforcement with other facilities similar to what was done with Northern Metals.” If another exceedance of the federal standard occurs, he warned, “it could trigger involvement of the U.S. Environmental Protection Agency.”

Other companies cited in the warning from David Thornton include Alliance Recycling, Cemstone, Aggregate Industries, GAF, and Willman Trucking.

## Marshall Street Re-construction

Overall, the Hennepin County plan for Marshall Street NE envisions a dedicated center lane for left turns and a two-way protected bike lane on the east side of the road. In addition, safer pedestrian crossings

are planned for 22<sup>nd</sup> Ave NE (near The Sample Room), 19<sup>th</sup> Ave NE (near Psycho Suzi's) and a pedestrian/bicycle crossing at 16<sup>th</sup> Ave NE that would connect walkers to the Park Board's new River path (that ends just west of Ollu Dog Wash) and bicyclists to the 18<sup>th</sup> Ave bike path that runs behind East Side Neighborhood Services (ending at California St. NE), essentially serving as a gap filler between the two off road paths. This new multi-use path connection would run just south of the BSNF railroad tracks, under the overhead Xcel electrical transmission lines, and wouldn't actually be on BSNF property. If you're in the area, check it out.

The Hennepin County board will vote on this plan for submission to the federal government in mid-May, 2018. If Federal funding is secured, the Marshall Street re-construction will begin in 2024. The City of Minneapolis might also provide a dollar match of 20%, or \$20 million.

The re-construction is long over-due but paving experts from Hennepin County public works believe they can patch Marshall St NE together for a few more years. The old granite paving stones from before 1900 are showing through the potholes in various places along this stretch of road. Beneath the surface some water mains and all utilities must be replaced. In all, the re-construction will stretch from the 1029 Bar (just south of Broadway) to St. Anthony Parkway on the north.

Marshall St NE is part of the national Mississippi River Trail that runs from New Orleans to Itasca State Park. It is also part of the National Historic Red Ox Trail that ran from St. Paul to Winnipeg in the 1850s before there were railroads to carry goods. These national historic trail designations

will hopefully make Federal funding more probable.
