BNA Board Elections

Many may be wondering what it is to be a member of the Board of Directors for a non-profit corporation. In the most legalistic form, there are three responsibilities of a nonprofit board: Care, Loyalty and Obedience. In other words, work for the best interests of corporation in a normally prudent manner, put the organization first and avoid situations that might create conflicts, and obey the laws and rules governing the organization. Pretty easy really.



For neighborhood organization involvement, this legalese translates to: 1) oversee the general business of BNA, 2) attend Board meetings, 3) volunteer at neighborhood events, 4) share your ideas, 5) encourage others, and 6) be positive and have fun.

This year there are four nominees running for two open seats – each for a three year term.

Please use the enclosed ballot to vote for up to two nominees. You may return the ballot by mail (we must receive it by October 25th for it to be counted) or you can drop it by the BNA Office at 2205 California St, #107 (and slide it under the door) or bring it to the October neighborhood meeting (see Notice to the right).

Lowry Bridge Open House

The public is invited to view conceptual renderings of proposed designs for the replacement Lowry Avenue Bridge and provide input on these designs. There will be a presentation starting at approximately 6:30 pm.

The technical and project advisory teams have narrowed the field of possible bridge types to three: concrete box, steel through-arch, and cable stayed. There will be two different conceptual representations for each type. The first will simply span the river; the other will reach west to the railroad tracks.

There may only be one other public meeting during this phase of determining the type of bridge.
