GAF – Toxic Fumes

The BNA office has been inundated with phone calls and emails regarding toxic fumes emanating from GAF Building Materials Manufacturing Corporation across the river at 50 Lowry Avenue North.



This is not a new problem. Area residents and business owners say the issue goes back at least 15 years.

In 2005, GAF representatives promised a new vapor recovery system that would eliminate their emissions problem, but residents contend this improvement was never made. So BNA called City Environmental Inspector, Megan Taylor, who stated that GAF is in compliance with the MPCA permit, No. 05300043-002. Further, she said GAF’s compliance officer is working with the City to find the cause of these odors. Calls to the Minnesota Pollution Control Agency yielded a similar response, this time from Pollution Control Specialist Brent Rohne who conducted MPCA’s most recent inspection on Oct. 24, 2013.

At Mr. Rohne’s suggestion, BNA contacted MPCA’s Air Monitoring Supervisor, Rick Strassman, who requested that neighborhood residents and business owners log the exact times and duration of the incidents when fumes are detected. Mr. Strassman also verified that the fumes emanating from the stack are carcinogenic and can adversely affect people with asthma and other lung conditions.

Being in compliance with an air permit can mean monitored emissions are okay in an area zoned for industry (like the riverfront industrial zone at 50 N. Lowry) but that doesn’t necessarily mean they’re okay for the residential areas into which they drift. The MPCA and EPA rules make it clear that **odors** are monitored by City health department and/or regulatory personnel. Unfortunately, the smells coming from GAF are not merely nuisance odors. Maybe the problem has been incorrectly defined.

In other words, the unpleasant odor of these fumes might be the least of our problems.

BNA encourages everyone who is concerned about these fumes to follow Rick Strassman's advice and maintain an accurate log of the times and durations that these fumes are noticeable in our neighborhood. Your first logs can be turned in at 7pm on October 2 at East Side Neighborhood Services where BNA will formally address this issue.

In addition, residents and businesses are encouraged to call 311 to register complaints. Unfortunately, because the fumes sometimes occur in the middle of the night when 311 is closed it is unclear if 311 call data reflects the actual times and dates of the incidents. Further, wind directions might also complicate the exact timing of reported toxic incidents.

Council Member Jacob Frey, City of Minneapolis, MPCA and GAF personnel have all been invited to the annual BNA elections and community meeting on **October 2, 2014** at East Side Neighborhood Services (1700 2nd St NE).

Save the date, show up and *make your voices heard*.

Legalize Grandmother's Apartment

The City of Minneapolis is undertaking a review of ADUs (Accessory Dwelling Units, also known as "grandmother apartments") with the aim of legalizing this type of residential unit. Town hall type open house meetings are being held throughout Minneapolis. In Northeast, this occurred on August 27, 2014, at East Side Neighborhood Services. Personnel from the City's

Community Planning and Economic Development agency (CPED) were on hand to explain the concept of ADUs and to ask for citizen input. In addition, there is a survey available for comment at:

Here are some basic facts gleaned from that meeting:

- ADU units cannot be any larger than the primary residential units
- The primary and ADU units would need to be owned by one property owner
- An ADU could be either detached from or attached to the primary unit
- An ADU could be either one or two stories
- Garages and carriage houses could be converted into an ADU
- Minimum square footage would be set at 200 sq. ft.
- It is anticipated that the primary residences will be homesteaded
- One of the City's aims is to allow multi-generational families to co-habit on a single lot
- Rental licensing and regulation of ADUs will bring existing undocumented units into code compliance

Here are a few unanswered questions:

- Currently one off street parking space is required per dwelling unit in Minneapolis—how many will be required for ADUs?
- What access requirements are necessary for fire suppression in adjoined ADUs or in detached ADUs?
- Should utility billing for ADUs be separate from the primary unit?
- Should there be an ADU height requirement?

- What should be the maximum ADU square footage?
- Should there be a minimum number of bedrooms?
- Should there be a limit to how many "relatives" can live with "grandma" in an ADU? (Currently, there is no limit to the number of relatives living together in a legal domicile)
- What will be the regulated leasing requirements and eviction processes when (God forbid!) grandmothers go wild?

In History
