

Accessory Dwelling Units

On June 27, 2014, Ward 10 Council Member Lisa Bender introduced an ordinance amendment to revise the zoning code to allow accessory dwelling units (ADUs) citywide. An ADU – also known as a “carriage house” or “granny flat” – is a dwelling unit that is an accessory to another residential structure, with its own kitchen, bedroom, and bathroom.

In August and September, staff hosted four open houses across the city and administered an online survey to gather feedback on the allowance of ADUs. An additional open house took place in late October, following the publication of the preliminary draft ordinance.

The draft ordinance would make the three ADU types (internal, attached, and detached) allowed citywide on the same lot as a single or two-family home.

MPCA Begins Urban Air Quality Pilot Project

The Minnesota Pollution Control Agency (MPCA) recently started a pilot project to improve Minneapolis air quality by working outside the typical regulatory box. The project aims to develop collaboration between local government, key sources of industrial emissions in the city, and the communities around those facilities. Its intent is to better understand and quantify air pollution from sources in Minneapolis and integrate what is known about air quality with the tools available for protecting human health and the environment.

Instead of focusing on individual facilities one at a time—the typical regulatory approach—the MPCA wants to look at these facilities as a group, working together with them and neighboring residents to identify ways of reducing emissions and making other changes which address community concerns.

The MPCA identified the following facilities as candidates for the pilot based on their emission levels of key pollutants and the concerns of nearby residents. All have agreed to participate:

- NRG Energy Center
- Smith Foundry
- University of MN—Twin Cities
- Metro Transit—Heywood Garage
- Bituminous Roadways, Inc.
- Greatbatch Medical
- GAF Materials Corp.
- Prospect Foundry
- Hennepin County Energy Center

The first step in the pilot is for the MPCA to make sure it has accurate information about emissions from these facilities so that we can best assess their impact on Minneapolis's ambient air quality. This may include air monitoring at some facilities and in surrounding neighborhoods. The MPCA also wants to improve communication between government agencies, the facilities, and area residents. Another step will be to identify options for reducing emissions from their current levels, including engaging technical assistance resources available from government agencies, the U of M, and others.

Air pollution also comes from numerous other sources, including vehicles, and is influenced by factors outside of our region; improvements resulting from this initiative may take time. However, the MPCA looks forward to working with these facilities, local government and community representatives to go beyond current requirements to improve Minneapolis air quality.

Air Quality Violation

The Minnesota Pollution Control Agency (MPCA) has found that air quality in an industrial part of North Minneapolis recently violated a state standard for large airborne particles.

"Although it isn't an immediate health threat, this is a situation that concerns us," said MPCA Industrial Division Manager Jeff Smith. "These larger particles are less of a health risk because they can't be inhaled deeply into the lungs like small particles. However, any violation of this nature is a serious matter."

The violation was detected by an air

monitoring station near the Lowry Avenue bridge on the west bank of the Mississippi River. Levels of large particles, also known as Total Suspended Particulates (TSP), exceeded the state standard on October 26 and November 1, 2014. This triggered an MPCA investigation into possible sources and corrective actions. That investigation is ongoing.

Metro Blooms: *Best Community Investment*

On November 6, Northeast residents **Macy Ashby** and **Todd Larson** (686 24th Ave NE, in Holland Neighborhood) were awarded Metro Blooms' *Best Community Investment Award* for 2014. Demonstrating how people can lead by example, Macy and Todd attended a Metro Blooms raingarden workshop, brought in 14 tons of rocks, planted native and perennial plants, then saved money by transplanting 300 daylillies from a giveaway and using free city mulch as groundcover. Afterward, they hosted neighborhood gatherings in their yard and doorknocked to spread the word about the environmental benefits of raingardens. As other homeowners got on board, students from the University of Minnesota's School of Design and the Conservation Corps of Minnesota began to assist with other raingarden installations. The result? 27 raingardens have been installed in Holland Neighborhood thus far! Leading by example, Todd and Macy created a beautiful landscape in their own yard and motivated others to make a big impact in their community and on our local lakes and rivers. A community investment like this can, and should, be an inspiration to us all.
