# Why Won't the Cottonwoods Grow?

Thanks to the Mississippi Water
Management Organization (MWMO)—
who provide guidance, cottonwood
samplings and funds—Northeast
RiverKeepers and other volunteers
from Bottineau Neighborhood have
now begun Phase Two of our River
stabilization project on Heron Island.
Invasive species have been eradicated
and the planting of native trees is
currently underway.

Everyone hopes that the cottonwood whips donated by the Mississippi River Fund—and the larger cottonwood trees purchased from the Tree Trust—will take root and survive.

Cottonwoods are nurseries of the skies, builders of river islands, and important shoreline stabilizers. They alert us to river health just as canaries once warned miners of an impending blowout. The group effort undertaken by the Northeast RiverKeepers and BNA is part of a study to help figure out why cottonwood trees are not establishing themselves naturally in our area. One cause may be the "flashing" (or extreme flooding) on the Mississippi in recent years, and many suspect this is due to a higher than natural influx of flood waters caused by agricultural tiling and by the ditching of steams up river.

Also helping with this project are volunteers from Dangerous Man Brewing. Good job everyone!

#### EEQL to Host Public Mtg

On Wednesday, September 16, at 7pm, Eastside Environmental Quality of Life (EEQL) will hold a public meeting to introduce **Tonye Slyvanus**, the Masters of Public Health candidate who is guiding our neighborhood through the process of conducting an air sampling study designed to find out what exactly is in the smoke coming out of the GAF stack just west of us. The meeting will take place at the offices of the Mississippi Water Management Organization (MWMO) located at 2522 Marshall St. NE.

GAF's emissions are not a new problem for our neighborhood—a 1994 letter sent to the MPCA about these fumes has recently been found in the BNA archives—but this new approach should establish the process necessary for solving this issue once and for all.

At the meeting, Tonye will present a progress report on his work, followed by a Q&A session. Down the road, after all the sampling has been completed and analyzed, Tonye will produce a human health assessment derived from the analysis as part of his final report to EEQL. In addition, he will also be researching solutions that have been successfully deployed by other companies in an effort to eliminate odors and fumes similar to those produced by GAF. Tonye is using this internship to produce his Master's Thesis at the University Of Minnesota Graduate School Of Public Health.

# A New Backyard on the Mississippi River

New Stormwater Park and Learning Center Demonstrates Sustainable Development, Green Infrastructure

The Mississippi Watershed
Management Organization (MWMO)
invites the public to celebrate the
completion of its one-of-a-kind
Stormwater Park and Learning Center
on Saturday, Sept. 19, from 10am
to 1pm.

The family-friendly grand opening celebration will feature tours, interactive exhibits and kids' activities. The event will mark the completion of the MWMO's public park and facility, which serves as a showcase of landscape features that save, clean and reuse stormwater.

"We have built a beautiful green space for people to enjoy—but more importantly, it's a place where people can see what green infrastructure looks like and how simple features like raingardens and tree trenches protect our natural resources," said MWMO Executive Director Doug Snyder.

The park is built around 11 unique, visible stormwater management features. Highlights include a green roof, a 4,500-gallon cistern, large raingardens with native prairie vegetation and a special experiment station to test different soil mixtures for filtering stormwater.

Opening the Stormwater Park and Learning Center involved removing nearly 18,000 tons of contaminated soil and restoring a piece of riverbank to its natural state. The project won a Minnesota Brownfields ReScape Award and provides a new public access point to the Mississippi River.

Funding for the solar thermal rebate was reopened in March to all Minnesota residents, nonprofits and businesses. Rebate applications will be accepted on a first-come, first-served basis through the end of the year or until all solar thermal funds have been fully committed.
