## CAMP: Community Air Monitoring Comes to Bottineau

Last month in the Gazette we announced that Community Air Monitoring was coming to Bottineau Neighborhood. On Sept. 22, Rick Strassman of the Minnesota Pollution Control Agency (MPCA) attended BNA's annual meeting and explained how the Community Air Monitoring Project (CAMP) will be carried out in our neighborhood.

Air testing, which begins in January 2017, will go on for a minimum of one year. During the first six months, the MPCA's monitoring will include tests for 57 different *Volatile Organic Compounds* (VOCs) as well as particulate testing for 2.5 PPM (parts per million) particles and 10 PPM particles. According to Mr. Strassman, 2.5 PPM particles are smaller than 10 PPM particles and are often breathed more deeply into the lungs.

Later, in July 2017, the MPCA will add tests for *Polycyclic Aromatic Hydrocarbons* (PAHs) to the ongoing VOC and particulate monitoring. PAH testing is especially important for our community because PAHs frequently smell like tar or creosote—a noxious odor we are all too familiar with in Bottineau—and are commonly associated with asphalt shingle plants like GAF Building Materials, located across the river from Bottineau at 50 N. Lowry.

CAMP, which is funded by the State of Minnesota, chose Bottineau as a testing site for two reasons:

1. Bottineau residents have frequently and consistently reported air quality issues to 311
2. BNA has worked tirelessly to show that air pollution has negatively affected the health of neighborhood residents

In other words, concerned citizens—organized and engaged with the community—really do make a difference. How can you make a difference now? Call or make online complaints to 311 whenever you smell tar or creosote odors. Be sure to mention the word "asphalt" and the address 50 N. Lowry so that your complaint will be registered correctly. You may remain anonymous.

## Election Results – Volunteers Make the Difference

Congratulations go out to those who are willing to serve on BNA's neighborhood board this year, and many thanks. Amanda Winterer, Koral Purdy, Matthew Ruby and Mariam Slayhi were all elected. Officers of the board will be chosen at BNA's monthly board meeting on Oct. 11, 2016.

But don't forget, there's another election coming up soon, and it's an important one. Remember to VOTE on Tuesday November 8. Make a difference, be a voter. Many people have died to preserve and expand our right to vote. Honor them by participating on Election Day.

## Minneapolis Public Schools 2016 Referendum

On Nov. 8, Minneapolis voters will be asked to renew the school district's current operating referendum authorization that expires after the 2016-17 school year. If passed, it ensures funding that will help Minneapolis Public Schools manage class sizes and provide supportive services and activities for students.

If approved, voters will be authorizing the referendum for nine more years, including annual adjustments for inflation. Property taxes are not projected to increase due to this approval.

More specifically, in the district's 2016-17 budget, the operating referendum will provide funding for:

- 591 classroom teachers to manage class sizes across the district
- 82 academic and behavioral specialists

- Math, science, and early literacy curriculum and materials
- Classroom technology

Just as importantly, this funding will also pay for student opportunities like tutoring, leadership development, mentoring programs and afterschool activities.

If the referendum fails, Minneapolis Public Schools will have to make difficult decisions about how to operate the district without a substantial portion of the budget. This may change the current services and opportunities that our schools provide for students and families, including class sizes.

## Second Precinct Advisory Committee (2PAC)

Every police precinct in Minneapolis has a Precinct Advisory Committee (PAC) and a name that corresponds to the precinct number. Northeast is in the Second Precinct, so our Precinct Advisory Committee is called 2PAC.

The whole point of the PAC is to facilitate 2-way communication between the police and the community they serve. It is not a forum for telling the police inspector how to run the precinct, but rather an opportunity for citizens to stay up to date with the Precinct Inspector's monthly reports, express concerns about what is going on in the community, and hopefully get some direction about how those concerns can be addressed. Sometimes these concerns are not police matters, as in

housing inspections, so PACs work to get issues like that sorted out and citizens directed to the appropriate City departments. Officials who are in charge of a City services department are frequently invited to speak at PAC meetings.

2PAC, the Second Precinct Advisory Committee, meets on the second Monday of every month at 1900 Central Ave. NE from 6pm–8pm. All precinct residents are welcome to attend. For more information, visit <https://courtwatch2pac.com/>
