## Impound Lot Update

On April 15, 2019, Council Member Steve Fletcher held a long and thorough discussion with Sheridan and Bottineau residents about the proposed impound lot at 1901 Grand St NE. Of the 64 neighborhood residents in attendance, not a single person spoke in favor of the proposed impound lot.

Since the meeting, Bottineau Neighborhood Association has done some fact checking regarding Bobby & Steve’s answers to community questions raised about the lot.

When asked a variety of questions about their existing Columbia Heights lot at 37<sup>th</sup> and Madison, Bobby & Steve’s answered with “no comment,” while adding that the two impound lots are not in any way connected. But this is a false statement. A quick call to Bobby and Steve’s towing line revealed that cars from anywhere in Minneapolis may be towed to any of the four impound lots that B&S operates, including the one in Columbia Heights and others in St. Louis Park, South Minneapolis (at Nicollet and 61<sup>st</sup>) and West St. Paul. The B&S towing operations to their four existing impound lots are clearly connected and relevant to the decision making process. All questions about MPCA storm and ground water orders to clean up pollution at the Columbia Heights impound lot are clearly relevant to issues about the B&S proposal to operate an impound lot

in our neighborhood and should have been answered truthfully and forthrightly.

Often the best indication of future corporate behavior is past behavior. Here are some specific questions about past behaviors of B&S that were posed at the meeting:

1) Does B&S move cars out of the lot at Columbia Heights on to City streets, unattended vacant lots and park property?

B&S: “No comment.”

Fact: B&S has been cited for these exact violations in Columbia Heights.

2) Has B&S fought MPCA orders to clean up ground water and storm water pollution caused by their towing operations in Columbia Heights and Minneapolis?

B&S: “No comment.”

Fact: Public records verify that B&S has been fighting MPCA orders to mitigate pollution caused by their impound lot operations.

3) Will B&S trucks tow to a lot at 1901 Grand ST NE from all directions? B&S says no, they will tow vehicles from only one direction on Marshall St NE and that they have GPS on their trucks to monitor the course and speed of their trucks.

Fact: B&S also uses sub-contractors whose trucks do not have GPS and are not monitored by B&S technology. Their answer to this question is an artful deception and essentially false.

Below are pictures from the B&S operated impound lot at 304 W. 61<sup>st</sup> St. in Minneapolis (61<sup>st</sup> and Nicollet).



Ugly fencing, hundreds of cars kept for auction, and 24-7 operations are the likely result of a B&S operated impound lot regardless of location. But the Nicollet Ave. impound lot has major road access from all directions. The site

proposed for our neighborhood at 1901 has access from only one road, Grand St. NE. To get there tow trucks will have to drive through blocks and blocks of residential neighborhood filled with family homes.

Explain to them why you oppose this impound lot.

You can also help with outreach by signing up to be on the public hearing alert system, or help with public records research regarding B&S's impound lot management. Contact BNA at 612-367-7262 if you want to get involved.

**Next Steps:** B&S has to submit a plan to city planners. Once a plan is submitted it will be subject to a Planning Commission review (the Planning commission meets the first Monday of every month at 4:30 in City Hall). Then it will go before the City Council Zoning & Planning Committee which meets at 10am on Thursdays of the first week of the City Council cycle (this date varies from month to month). Then the full City Council will vote on the impound lot. At every step of this process, concerned residents need to be ready to act.

Northeast is plagued with zoning that allows areas zoned for industry to exist right next to areas zoned for residential housing. This is an unfortunate disadvantage that exposes local residents to industrial

pollution — on their property and in their homes — without protection from City of Minneapolis zoning rules that protect other areas of the City.

Northeast is the most pollution-burdened area in Minneapolis and, therefore, the State of Minnesota. Bottineau is already burdened with ground water, air and soil pollution that we are working hard to address and alleviate. Maybe you remember the signs from a number of years ago that said, "Don't Dump on Northeast." Now is the time to let the City of Minneapolis know that Northeast is no longer the City dump. We expect better.

## Standout Bottineau Student: Jasmine Smoter



In March, 2019, Jasmine Smoter (3<sup>rd</sup> from left in the photo above) and the other students pictured were recognized by Council Member Kevin Reich for earning the opportunity to represent Edison High School at Tours France, a City of Minneapolis Sister City.

Students were housed with local families to ensure an authentic cultural experience. Jasmine, an Edison volleyball outside hitter and softball shortstop, said that her favorite part of the trip "was the real experience of French life ... I learned how to speak French much better and got to attend a volley ball game."

Students were chosen based on

their fluency in the French language (Edison has an International Baccalaureate French program), having good grades and being positive role models in school and assets to the community.

Jasmine is the daughter of Bottineau residents John Smoter and Koral Purdy. For many years, Jasmine has helped the neighborhood by providing child tending so parents can participate during community meetings and has also helped recruit other child tending volunteers when needed. On many occasions, Jasmine volunteered to help with meeting set-up and clean-up at East Side Neighborhood Services. Thank you, Jasmine, for representing Bottineau in our Sister City and for being a great example for the neighborhood!
